- As a convenience to our families, we have listed the most commonly asked questions concerning our cemetery. The items listed are not a complete list of our rules and regulations. The complete list can be reviewed in the cemetery office.
- 2. The Rules and Regulations have been adopted for the mutual protection of owners of Interment Rights in the cemetery. All property owners, persons within the cemetery, and Interment Rights sold shall be subject to these Rules and Regulations as they now exist and as same may be reasonably hereafter be amended or altered by the cemetery.
- Palm Beach Memorial Park is a perpetual care cemetery that is designed for the burial of human remains.
- 4. Ground level bronze memorials resting upon a granite base are the only memorials allowed in the cemetery. Approved bronze sizes for companion adult memorials are 56x16, 44x14, 44x13, 36x13, 24x30, and 16x24. Approved bronze sizes for single adult memorials are 24x14, 24x13, and 24x12. In addition, the Garden of Abraham permits the use of ground level, cut granite markers in the size 24x12 for single memorials and 36x13 for companion memorials.
- 5. No trees, shrubs, or plants will be planted on a grave space, right of way, or easement.
- The cemetery is not responsible for theft or damage to anything placed on or near grave spaces, mausoleum crypts, or niches.
- 7. There will be no parking of automobiles off the paved roads.

- All interments, entombments, or inurnments must be authorized by the next of kin or individual that has the legal authority.
- 9. No enclosure of any kind is permitted around any grave, lot, or memorial.
- The general care of the entire cemetery grounds and lots is assumed by the cemetery under the provisions of a Care and Maintenance Trust Fund.
- 11. The cemetery, as part of its rules and regulations on file in this office, has established procedural installation requirements for the installation of vaults, memorials, foundations, and all installations performed within the cemetery.
- 12. No floral arrangements, pictures, cards, notes, or other objects will be taped or placed on or between crypts in any mausoleum building or niche bank. Only items that may be safely placed in an approved vase are allowed.
- 13. All Interment Rights that are transferred or exchanged must be authorized by the cemetery and the appropriate fees paid.
- 14. The cemetery reserves and shall have the right to correct any error that may be made in the locating of an interment space or placing of a vault, memorial, foundation, or other embellishment in the cemetery.
- 15. The speed limit within the cemetery shall be no more than 20 miles per hour.
- 16. Only one floral arrangement per lot or grave shall be permitted and then only in a vase or receptacle approved by cemetery management. Potted plants are not permitted except on the following days: Easter, Mother's Day, Memorial Day,

- Father's Day, Christmas, and for a period of seven (7) days after the special days hereinabove set forth. All other Christmas and Easter floral arrangements shall be permitted for a period of thirty (30) days following the holiday.
- 17. The cemetery reserves the right to remove all flowers, potted plants, or grave blankets when they become withered and in any event, all such items shall be removed with five (5) days from the date of the funeral service.
- 18. All floral decorations shall be removed for semi-annual cleanup periods. The cemetery will not be responsible for retaining, storing, or returning any floral arrangement or grave decoration to the respective families.
